Attendees and Exhibitors

Q: How many attendees are expected to attend this year? A: Since the event is open to the public and we are doing extensive marketing and promotion, we expect around 100-150 visitors each day.

Q: How many companies are expected to attend this year? A: We are aiming for a total of 69 companies representing different sectors and industries this year. Last year, we had 45 companies participate.

Q: Is there a limit to the number of attendees or representatives from an exhibitor company who can join the event? A: Each exhibitor is provided with 1 free ticket for networking. If you register as an exhibitor, one person can attend free of charge. Additional representatives can join with the purchase of additional networking tickets.

Booth and Decorations

Q: Will there be side walls between each exhibitor booth or a backdrop wall? A: Yes, there will be side walls between each exhibitor booth. Please refer to the sample booth photo for your reference.

Q: What is the booth area size and how can we decorate the booth space (e.g., rollup banners, TVs, sound system)? A: The booth area is 3m x 2m. You are free to decorate the booth space with rollup banners, TVs, sound systems, etc. Please refer to the attached layout plan and booth setup instruction and rules document for more details.

Q: Are there any items provided for the exhibitor booths (e.g., table, chairs, booth frames, power sockets, TVs)? A: Each booth area includes a 3m x 2m square box with 2 chairs, 1 table, 1 dustbin, 1 light, and a header with the name of your company. You can bring your own TV if you wish to have one.
